

As a result of the global economy being affected negatively by most of the world due to the Corona virus, the side effects on the Egyptian economy are as follows:


a-Low foreign currency reserves

 - B- Decreased economic activity, business and exports in the private sector, as a result of the precautionary measures taken by the government to combat the Corona virus crisis.


Industrial production


Tourism

Among the efforts of the country are extensive and extensive advertising campaigns to educate citizens about the dangers of the virus, how to prevent it and ways to protect against the spread of infection



Environment

Despite the negative impact of the Coronavirus, on the other hand, it had a positive effect on the decrease of pollutants in the atmosphere for the following reasons:

- 1- Lack of gaseous exhaust emissions from planes to stop the movement of global aviation
- 2- The result of the precautionary measures, which include domestic isolation and remote work, and led to a decrease in the gas pollutants resulting from the transportation means
- 3- As a result of the sharp decline in the industries, the greenhouse gas emissions from the factories have decreased significantly

All this led to a decrease in pollutants in the atmosphere

Pictures monitored by European space agencies and NASA showed a 70% decrease in pollution compared to the same period before the epidemic appeared

It is known that the low pollution rate in the environment positively affects the recovery of the weight layer and leads to the contraction of the weight hole
