
Dear Professor Hashem,

Memorandum of Understanding

This document serves as a Memorandum of Understanding (MOU) between the Board of Regents of the University of Nebraska a corporate public body, for and on behalf of the University of Nebraska Medical Center (hereinafter called "UNMC"), 987810 Nebraska Medical Center, Omaha NE 69198, United States of America and Heliopolis University for Sustainable Development (hereinafter called "HUSD"), an institution of higher education located in 3 Cairo-Belbeis Desert Rd., Cairo, Egypt.

Purpose

UNMC and HUSD enter into this Memorandum of Understanding to establish cooperation between faculty members **to explore potential collaborative projects in education, research and clinical health care.**

Discussion and Development of Possible Collaboration

Within the fields of education, research and clinical health care, to be mutually designated, both parties agree to discuss and explore the development of any one or more of the following general forms of cooperation:

1. To exchange information about medical and public health best practices in order to improve adult and child health in both countries.
2. To collaborate on medical, education, and research initiatives of mutual interest in both countries
3. Foster collaborative, respectful relationships and open communication across cultural and geographic boundaries, in both healthcare settings, in order to achieve the above-mentioned educational and research initiatives.
4. Exchange of research materials, publications and information
5. Development and operation of joint academic programs
6. Support for distance learning courses
7. Organization of joint research programmes
8. Exchange of students, residents, fellows, academic, and administrative staff & other non-academic staff for purposes of education, training and research
9. The development of common curricula in areas of mutual interest

10. Organization of joint conferences or workshops in (research) areas of mutual interest

Term of the MOU

This MOU takes effect on the date it is signed by authorized representatives from participating institutions and will continue in effect for 3 years. The term of this MOU may be modified at any time by mutual consent and either party may cancel the MOU at any time, with or without cause, and without any obligation beyond those which may be established by subsequent additional written agreement between the parties. Further, this MOU shall not be construed as exclusive such that either or both organizations may enter into similar arrangements with other parties as they solely may deem appropriate.

As specific projects in education or research are identified and mutually agreed upon, each will require a separate written agreement which will set forth the terms and conditions of the project(s). These separate agreements will not be valid unless and until approved and signed by appropriate administrators at each institution.

Use of Names

All parties agree that they will not use the name, logo, registered trademarks or other symbols of the other party in signatures, headings, letterhead, brochures, announcements or any other way without the prior written consent from such party, which consent may be withheld or conditioned in that party's sole and absolute discretion.
